An Open Exhibition of the Work of NCAS Artist Members

Following the success of the biennial NCA08, NCA10, and NCA12, the Norfolk Contemporary Art Society (NCAS), in collaboration with The Forum, is delighted to announce **NCA14**, a major open selling exhibition of recent paintings, prints, photographs, drawings, textiles, videos and sculpture by artist members of NCAS. The exhibition will be held in The Forum, Norwich from Monday 3rd March to Saturday 15th March 2014.

SELECTION PANEL

The selection panel comprises Carl Rowe (NUA), Frances Kearney (artist), Sarah Bartholomew (SCVA) and Keith Roberts (NCAS), together with members of the NCAS Exhibitions sub-committee.

SUBMISSIONS

Artist members of NCAS are invited to submit images of up to three recent works, completed between 2011 and 2014 and **not** previously shown in public. Images must be supplied on a CD (preferably in JPEG format, with each image below 3MB in size). The CD, together with a completed submission form, should be sent by post to arrive before **Friday 20th December 2013**. Please do NOT send original works at this selection stage. Two-dimensional works must not exceed an overall size of 2.0 m in height and 2.5 m in width (including any frame if present). The selection panel will meet on 3rd January 2014.

All work must be offered for sale, and the price must include VAT if applicable. There is a one-off total submission fee of £10, and a commission of 25% will be charged on all sales, to be shared equally between the two charities, NCAS and The Forum. The Forum will act as agent for the artist.

The exhibition will occupy all of the atrium exhibition space. A fully illustrated colour catalogue will be produced.

Members are reminded of the nature of The Forum, which is a public space, freely open from 7 a.m. to midnight, seven days a week, and which attracts around 50,000 visitors a week. The works in the exhibition will be insured but, whilst every care will be taken of the accepted works, neither The Forum nor NCAS can accept responsibility for any loss or damage to work in the exhibition. NCAS will arrange for stewards to be present at the exhibition between the hours of 10.00 a.m. and 6.00 p.m.

Copyright in all works, including those illustrated in the catalogue, remains with the artist.

N.B. If you know of any local artists who are not members of NCAS, but who would be keen to submit work to this exhibition, then please do encourage them first to join the society quickly, using the NCAS application form, and then to complete a submission form. Both forms can be downloaded from the website at www.n-cas.org.uk.

If you feel able to help this ambitious exhibition, by volunteering to act as a steward for a morning or afternoon session during the show, then do tick the relevant box on the submission form. If you are not submitting work but would still be willing to act as a steward, then please let Keith Roberts know in the first instance.
